## ENGIE and Powerdale selected to provide Luxembourg with 800 public charging stations

**Luxembourg, August 8, 2016, the consortium between ENGIE Cofely Luxembourg (subsidiary of ENGIE) and Powerdale announced it has been selected to provide 800 public charging stations in Luxembourg and to operate them during a 12-year service contract.**

The consortium between ENGIE Cofely Luxembourg and Powerdale has been selected after a European tendering process by the 5 Luxembourg distribution grid operators (Creos, SudStroum, Electricis, Ettlbruck and Diekirch cities) to provide 800 public charging stations, to be installed on a 4-year period (2017-2020) and to manage the “Common Operator Platform” during a 12-year service contract. Powerdale, a company developing complete solutions for electro-mobility and energy management, will deliver the charging stations and the internet application for the “Common Operator Platform”; ENGIE Cofely Luxembourg, a subsidiary of ENGIE delivering services to industrials and public sector, will operate the infrastructure.

200 Nexttender charging stations of Powerdale will be installed each year from 2017 to 2020. The Nexttmove IT service platform created by Powerdale will be available for electrical vehicle (EV) drivers and every player taking part in this new kind of mobility: distribution grid operators, energy suppliers and mobility service providers. It will allow the end user to pay its charging whichever mobility provider he will choose. The system will be interfaced with the Luxembourg Public Transportation Services in order to offer a multi modal system to the end users.

*“These contracts are significant steps in the development of electro-mobility on the Luxembourg territory, and position us on the map of the major EV players in Europe. With our local entity, we will support the open operation model proposed by the grid operators and this will allow all electro-mobility players to develop green mobility in Luxembourg”,* said Pierre Wolff, General Manager of ENGIE Cofely Luxembourg.



*“The tenders written by the distribution grid operators were totally in line with our long term vision on the needs of electro-mobility developments: ease of use, energy management, flexibility in terms of adaptations of hard- and software in function of market evolutions, smart grid oriented with intelligent charging stations. We thank the distribution grid operators for their confidence and recognition of our electro-mobility and energy management expertise”,* mentioned Olivier Piraux, CEO of Powerdale.

These public charging stations will be the first provided by ENGIE Cofely Luxembourg and Powerdale in Luxembourg, where there is already more than 200 stations installed.

As part of its strategy to be a leader of the energy transition in the world, ENGIE has also announced earlier this year its decision to invest nearly 100 M€ from now on to 2020 in the setup of Compressed Natural Gas (CNG) and Liquefied Natural Gas (LNG) stations for filling up the European fleets of vehicles with natural gas and biogas.

ENGIE has invested in Powerdale in 2014 via “ENGIE NEW Ventures”, its venture capital dedicated to innovative startups.
